

GENERAL ORDER NO. 203.


Subject: Immigration Border Patrol.

Effective June 1, 1933, General Order No. 183 (Mexican Border, Gulf and Florida District) and General Order No. 184 (Canadian Border District), dated January 5, 1932, and district orders issued thereunder, ~~are~~ ^{are} repealed.

Effective the same date, General Order No. 61, dated March 18, 1926, the amendments and supplements thereto, the orders issued thereunder, and all other orders or instructions pertaining to the Border Patrol in effect prior to January 5, 1932, are reinstated and will remain in full force and effect until otherwise ordered.


Beginning with June 1st, the Border Patrol Service will operate in accordance with the provisions of General Order No. 61. (See General Order No. 203.)

Under this readjustment, the Border Patrol personnel in the various districts will be transferred to the jurisdiction of the respective Commissioners and District Directors.

The Directors of Border Patrol will immediately prepare and forward to the Bureau a list of the personnel in their respective districts, together with the place where located. They will also prepare and forward to the Bureau an inventory of all equipment, exclusive of records, together with the location thereof.

The personnel files in the respective headquarters of the Border Patrol will be transferred to the immigration district headquarters of the districts in which the Border Patrol employees are respectively located. Any other files relating exclusively to a district will be transferred to the immigration district headquarters for that district. All other files will be retained in the Border Patrol district headquarters pending further disposition.

To carry out the purpose of this rearrangement, the Commissioners and District Directors in charge of districts in which the Border Patrol operates will forward at the earliest practicable date any recommendations pertaining to transfers of Assistant Superintendents, or other employees identified with the Border Patrol, or otherwise, which they may desire to submit.
